LOOKING BACK

Our sampling season seems to have come and gone with swift movement through our lives. Volunteers dedicated weeks of sampling and transport of critical data that informs us on the health of our river. A question we receive all too often is "How is the water quality of [site indication]". It is always difficult to answer this inquiry because - there is not one way answer to this question. Natural systems are constantly changing and in order to give a broad stroke answer, long term studies of the environment in question need to be completed. Even then, it is complicated since there are many changing factors that influence the system constantly. The following geometric mean (gm) calculations of the 2021 season are just that, a represented central tendency based on the single samples collected throughout the season.

These numbers do not correlate with words such as "good" or "bad"; but rather, "needs continuing research" or "needs additional support" - because no two sampling days are the exact same and no moments of sampling collection contain the same sample. We look forward to continuing our research of the Saw Mill and Hudson River and providing stakeholders, such as yourself, with information that supports the continued learning of our environment.

GEOMETRIC MEAN (GM): is the average value or mean which signifies the central tendency of the set of numbers by finding the product of their values.

DATA

*Most Probable Number of Colony Forming Enterobacteria per 100ml sample. EPA recommends public notification and possible temporary beach closure for single Enterobacteria samples above 60 cells/100ml. Samples testing above this threshold appear in red on the Riverkeeper website, while those below it appear in green. To avoid exposure to chronic contamination, the geometric mean, a weighted 30-day average, should not exceed 30 cells/100ml. To avoid exposure to occasional high levels of contamination, no more than 10% of samples should exceed 110 cells/100ml.
